FUNCTION:

The City of Ankeny is accepting applications for the fulltime position of Utilities Operator - Water in the Municipal Utilities Department.

Starting salary, plus excellent benefits:

- Utilities Operator Assistant - **\$22.06** per hour with no certifications
- Utilities Operator I - **\$24.52** per hour with a Grade I Water Treatment or Water Distribution operator certification from the Iowa DNR
- Utilities Operator II - **\$26.96** per hour with a Grade II Water Treatment or Water Distribution operator certification from the Iowa DNR

Hours are Monday - Friday, 7 AM - 4 PM with additional on-call/overtime hours as needed.

Applications must be received by Sunday, November 28, 2021 at 11:59 PM. Interested individuals should apply and may attach a resume along with any certifications held and a detailed cover letter expressing interest. *Pre-employment physical, drug screen and background check required.*

*To advance in the hiring process, you must pass a civil service exam to be administered to all qualified applicants. Additional information will be emailed on **Monday, November 29, 2021.** Please check your email (and junk email) for testing information. Contact HR if you do not receive the testing information on 11/29/2021.*

PRINCIPAL DUTIES AND RESPONSIBILITIES:

- Assist semi-skilled and skilled operation and maintenance of the Municipal Utilities facilities water distribution system and treatment wells.
- Record and interpret readings from meters, gauges, lab data, and related controls and equipment to maintain proper pumping rates, flows, and treatment processes and to make necessary operational or mechanic adjustments.
- Assist the public by listening to complaints, inquiries, and problems and taking the appropriate actions necessary to correct them and advise the supervisor or administrator when necessary.
- Respond to water main breaks; water service calls, and other emergencies as directed.
- Perform basic field tests.
- Obtain various water samples.
- Assist other city departments as directed.

ENTRY REQUIREMENTS AND SKILLS:

- Graduation from high school or an equivalent.
- Ability to establish and maintain effective working relationships with co-workers and the public, ability to keep accurate and legible records, and have the ability to recognize occupational hazards and follow established safety precautions.
- Shall maintain a valid driver's license issued by the State of Iowa and "may be required" to obtain a commercial driver's license (CDL) issued by the State of Iowa as a condition of employment.
- **Utilities Operator Assistant–Water** - If hired with no certification, must be able to obtain, within one (1) year from date of hire, a Grade I operator's certificate issued by the State of Iowa in a water related field.
- **Utilities Operator I-Water** – One (1) year of combined experience in the operation and maintenance of a water distribution system or a water treatment facility. Or possess an equivalent amount of education and experience recognized by the Iowa Department of Natural Resources. You must be a Grade I operator in Water Treatment or Water Distribution.
- **Utilities Operator II-Water** - Three (3) years combined experience in the operation and maintenance of a water distribution system or a water treatment facility. Or possess an equivalent amount of education and experience recognized by the Iowa Department of Natural Resources. You must be a Grade II operator in Water Treatment or Water Distribution.

WORKING CONDITIONS:

- Will be required to perform duties during off-hours emergencies, weekends, or holidays.
- May be exposed to a variety of chemicals, noxious odors, gases, high voltage, and other potentially hazardous working conditions as well as all types of weather conditions and extremes.
- Will be required to operate employer's vehicles and related equipment.

PHYSICAL REQUIREMENTS

- Must be insurable.
- Must be insurable.
- Must be sighted.
- Must be able to hear normal conversation and speak clearly at normal rate of conversation.
- Must keep regular and reliable attendance of work.
- Must be able to kneel, squat, bend, twist, climb, lie on creeper, and work over head.
- Must be able to work on equipment located overhead, above or below the waistline.
- Must be able to work in wet environments.
- Must be able to climb into and out of employer's equipment.
- Must be able to remove and replace manhole covers with a lever.
- Must be able to climb into and out of 24 inch openings.
- Must periodically lift and carry, for short distances, heavy objects weighing up to 75 lbs.
- Must be able to climb and descend ladders and stairs, and walk on uneven terrain.
- Must be able to lift and move items weighing up to 150 lbs. with the assistance of another employee but without assistance of a portable hoist.
- Must be able to use tools weighing 30 lbs. or more.
