JOB SUMMARY:

Under the general supervision of the Director of Water Distribution, provides technical training for new and existing employees, specifically spending time in the field teaching and mentoring. Promotes safety and ensures safety rules are followed.

EXAMPLES OF ESSENTIAL JOB FUNCTIONS:

- Provides technical and safety training for all new, transfer, and existing field operation employees.
- Performs training to employees on safe working practices, proper equipment use and operation, emergency procedures, and inspections.
- Maintains a high level of technical training, safety, and compliance knowledge to evaluate personnel and equipment readiness. Assists in developing and reviewing programs and procedures to assure compliance with regulations, codes, and standards regarding occupational health and safety.
- Develops, implements, trains, documents, and administers work and safety procedures and policies designed to promote workplace safety.
- Teaches a wide variety of work and safety topics in the classroom and on the job site for field operation employees. Including establishing traffic control, classifying soil, and determining proper shoring methods to meet OSHA and DOT requirements.
- Actively engages all field operation employees in promoting, recognizing, and developing a safe work environment supported by individual accountability.
- Promotes safety by modeling safe work behaviors and supporting safety initiatives.
- Gives technical support to field operation employees engaged in maintenance, repair, construction, and restoration related to the water distribution system.
- Protects water quality in the distribution system by working with employees to follow water quality procedures including isolation, repair, flushing, and sampling guidelines.
- Coaches field operation employees for improved technical skills. Provides on-the-job training and assists the management team with skill assessment.
- Performs other duties of a similar nature.

At least five of increasingly responsible experience working in maintenance and construction of a water distribution system.
