### **ESSENTIAL FUNCTIONS:**

- Installs and repairs new and existing electrical, plumbing, and pneumatic systems
- Responsible for trouble-shooting mechanical and electrical equipment
- Repairs and maintains boilers and heating systems
- Inspects and maintains water treatment and testing equipment
- Constructs and repairs structures for buildings/grounds
- Measures and records well drawdown readings
- Completes assigned work orders in a timely manner
- Responds to after-hours emergencies
- Fills plant operation shifts as directed
- Participates in treatment plant safety meetings
- Maintains a safe working environment at all job sites, using all required safety equipment

## **ESSENTIAL REQUIREMENTS:**

- Successful completion of High School or GED
- Must have basic oral and written communication skills
- Basic plumbing, electrical, and carpentry skills
- Ability to utilize voltage testing equipment
- Ability to read and understand blueprints
- Basic knowledge of the use of hand tools
- Willingness to develop skills and obtain needed licenses
- Possession of a valid Iowa driver's license with a good driving record
- Able to obtain valid Iowa DNR Grade II Water Treatment Certificate within 39 months of appointment; training resources will be provided by MWW

### PREFERENCE WILL BE GIVEN to individuals with the following:

- Five years of experience in industrial equipment maintenance
- Grade 1 or higher Iowa DNR Water Treatment Certificate
- One year of recent experience in water treatment plant operation
- Post high school certificate or credit hours in the water treatment field

# **ESSENTIAL PHYSICAL DEMANDS:**

- Occasionally handles up to 100 pounds and lifts 60 pounds
- Frequently climbs stairs and ladders and works on catwalks
- Ability to differentiate machine operational sounds
- Continuously walks, stands, squats, bends, kneels, twists or reaches overhead
- Occasionally handles high-pressure fire hoses
